# Land Acquisition

WHEREAS, the <u>Charter Township of Portage</u> supports the submission of an application titled, <u>Hurontown Soccer Fields</u> to the <u>Michigan Natural Resources Trust Fund</u> for <u>the acquisition of nine acres</u> (<u>Parcel Number 31-010-251-001-50</u>) for the future development of a soccer complex <u>immediately adjacent to our Hurontown Recreational Area</u>; and

WHEREAS, the proposed application is supported by the Township's 5-Year Approved Parks and Recreation Plan; and,

WHEREAS, the <u>Charter Township of Portage</u> is hereby making a financial commitment to the project in the amount of \$23,500.00 matching funds, in cash; and,

WHEREAS, if the grant is awarded the applicant commits its local match and donated amounts from the following sources:

<u>Copper Country Soccer Association</u> \$37,200.00 (donated amount)

Three Church Consortium \$4,000.00 (donated amount)

Total \$41,200.00 (sum of donations)

NOW THERE FORE, BE IT RESOLVED that the <u>Charter Township of Portage</u> hereby authorizes the submission of a <u>Trust Fund Grant</u> application for <u>\$187,500.00</u> and further resolves to make available a local match through financial commitments of <u>\$64,700.00</u> (25.6%) of the "total" <u>\$252,200.00</u> project cost, during the 2108 – 2019 fiscal year.
