# Charter Township of Portage Regular Board of Trustees Meeting

June 14, 2021

The Charter Township of Portage held a Regular Board of Trustees Meeting on Monday, June 14, 2021 via Zoom meeting.

Call to Order: The meeting was called to order by Bruce Petersen at 10:30 AM

**Approval of the Bd. of Trustees Previous Minutes:** A motion was made by Ollila and seconded by Bingham to approve the May 10, 2021 meeting minutes. Motion carried by a voice vote. Absent: Fink

**Approval of the Bills:** Anderson commented that the Township went over sewer with the City of Houghton 6 days last month in the amount of \$523.77. Bingham commented that the Township went over 50,000 gallons 24 days.
