- <u>Water/Sewer Committee:</u> Any follow up from Water/Sewer committee regarding my request to increase fees/ look at budget deficits? Portage Sewer and Dakota Sewer are both in a deficit, it is decreasing, but should not be in the negative at year end. No rate changes have been made to date this year.
- <u>Cemetery</u>: currently is -\$31.731.22; last year at this time it was -\$13,210.30, the prior year it was -\$26,748.95
- <u>Summer tax collection</u> is complete; late summer property tax bills for the current year can be paid through Feb. 28 at the township office

- <u>Rural Development/Portage Sewer</u> working on confirmation of min. account balances for new PS RD loans no updates, waiting on confirmation from Crystal at RD
 - Portage Sewer and Dakota Sewer are currently negative and may need "bail out" "due to general fund" at year end
